

Additional requirements for contractor registration -Grade B:

1. A separate Testing and commissioning Engineer is to be provided. The T&C Engineer shall either hold a bachelor's degree with 7 years' experience or diploma in Electrical Engineering with at least 10 years' experience with proven track record in testing & commissioning works. Also, the engineer shall have a testing & commissioning engineer license from DCRP. Appendix-A contains a form to be filled for the testing engineer.
2. A separate draughtsman & surveyor shall be provided. The qualification & experience requirements of both draughtsman & surveyor are as follow:
